NC Homeless Education Program

The McKinney-Vento Education of Homeless Children and Youth Assistance Act is the primary piece of legislation dealing with the education of children and youth experiencing homelessness. The Act is also known as Title IX, Part A of the Every Students Succeeds Act.

THE EVERY STUDENT SUCCEEDS ACT LINK

On December 10, 2015 the President signed into law the Every Student Succeeds Act of 2015 (ESSA), which reauthorizes the Elementary and Secondary Education Act (ESEA). Under the previous version of ESEA (the No Child Left Behind Act), the education of homeless children and youth was included in Title X, Part C. Under ESSA homeless education is included in Title IX, Part A.

Most Commonly Presented As

DOUBLED-UP

 Doubled-up is the informal wording used to describe a concept included in the McKinney-Vento Act's definition of homeless. It refers to shared living arrangements, some of which may be considered homeless, while others may not be, depending on various factors.

HOTEL

 Individuals who lack a fixed, regular, and adequate nighttime residence. Children who are currently living in motels, hotels, and or campgrounds, due to alternative living conditions.

UNACCOMPANIED YOUTH

 Any student not living in the physical custody of a parent/legal guardian. The school district ensures that children and youth, including unaccompanied youth, experiencing homelessness enroll and have a full and equal opportunity to succeed in school.
