Role of the Liaison

- Must inform UHY of their independent status for the FAFSA, and assist in obtaining documentation of this status.
- Have the option to make subsequent year determinations for UHY if they have access to the information necessary to make such a determination

Accompanied Homeless Youth

- Accompanied: In physical custody of a parent or guardian
- Homeless: Living arrangement meets the McKinney-Vento definition of homeless
- Students experiencing homelessness with their families fill out the FAFSA as dependent students and include parental financial information and signature
- Federal aid packages are calculated based on student plus parent's income and assets
- Homeless students from low-income families usually qualify for the maximum amount of federal aid

Unaccompanied & Homeless or At-Risk of homelessness

- UHY and unaccompanied youth at risk of homelessness complete FAFSA as independent students
 - Unaccompanied: Not in the physical custody of a parent or guardian
 - Homeless: Living arrangement meets the M-V definition of homeless
 - At risk of homelessness: When a student's housing may cease to be fixed, regular, and adequate, for example, a student who is being evicted and has been unable to find fixed, regular, and adequate housing

Independent students

- Do not have to include parent financial information or parental signature on their FAFSA
- Federal aid packages are calculated based solely on the student's own income and assets



Determiners of Independent Status

- Local homeless education liaison for high school seniors who were identified as UHY while in high school; can make subsequent year determinations for students in college
- U.S. Department of Housing and Urban Development (HUD) shelter director or designee - for students who have received services
- Runaway and Homeless Youth Act (RHYA) shelter director or designee - for students who have received services
- Financial Aid Administrator (FAA) for any student, but particularly those who cannot get a determination from one of the other three authorized parties
